

Proposed Amendments to the ICIS Bylaws July 2024

OVERVIEW:

The purpose of committees, whether standing or ad hoc, is to serve the needs of the Society and aid the Council in doing its work. Over time needs may change. Yet, because Standing Committees are enumerated in the bylaws, changing or eliminating them requires a vote of the membership. Only absolutely necessary committees need be standing committees.

In March of this year the Council discussed several changes to the standing committees to better reflect the society's current needs. The Managing Director then worked with the Executive Committee to document the proposed changes, which are outlined here. The Council approved the proposal in June and are now submitting it to a vote of the membership.

ANALYSIS:

The following table shows the existing language and proposed changes, which are highlighted in red. The comments column includes additional rationale.

They shall interact with the World Health Organization with respect to identifying and defining reference materials for cytokines, cytokine receptors and corresponding ligands involved in induction of cytokines. The Nomenclature Committee shall consist of a Chair and up to 6 members of the Society appointed by the President with the approval of the Council. The Nomenclature Committee shall advise the international scientific community as to the appropriate classification of genes as interferon or interleukin genes. They shall evaluate the data in support or against such designations and they shall inform the major scientific journals if genes are to receive the interleukin or interferon designation. 12. Membership Committee & Communications Committee. The Membership & Communications Committee shall consist of two Co-Chairs or a Chair and up to 10 members of the Society appointed by the President with the approval of the Council. The Scientific Program Committee Chairs of all confirmed future Annual Meetings will be appointed to the Membership / Communications Committee with the goal of increasing awareness about the Society and increasing membership in the local area where the future Annual Meeting will be held. The Membership & Communications Committee shall advise the Officers and Council as to steps needed to retain and expand the membership base.
